

Research agreement

This agreement is executed on the day: between
Jewish Family Search
hereinafter "the Researcher"
and
hereinafter "the Customer"

The agreement is as follows:

1. The Researcher agrees to search for:

The research of the aforementioned sources will hereinafter be called "the Project".

- 2. The Researcher will make every effort to complete the Project within ____ hours of archival work.
- 3. Should it be the case, after initial examination of the sources in the Archive, that it is impossible to finish the research within the specified time frame (e.g. due to unavailability of the documents or their unexpected volume), the Researcher will include a precise explanation of the reasons in the final report.
- 4. The Researcher will complete the Project within two months since this agreement is signed.
- 5. The Customer will receive a complete research report within one week after the research is accomplished. The report will include reference numbers of the documents researched, data extractions from relevant documents, and a brief summary written in narrative. Translation of narrative sources is not included in the report.
- 6. The Researcher will conduct the Project in accordance with strict standards of academic excellence.
- 7. The Customer agrees to transfer the funds for the Project to the amount of ____ USD by PayPal directly to info@jewishfamilysearch.com within one week of the signing of this agreement.
- 8. The Customer agrees to reimburse additional research costs related to service fees charged by the archives (e.g. for reproductions, faster document delivery, telephone orders) within one week after the research is completed and the receipts shown to the Customer. Additional research costs cannot exceed the amount of 50 USD.
- 9. Additional research which is does not result from this agreement is charged at 25 USD per hour (200 USD per day).
- 10. The Customer has right to withdraw from this agreement within 14 days since the date of its signing without providing any reason for the withdrawal. The withdrawal term is over 14 days the agreement is signed.
- 11. Should it be the case the Project is accomplished in less than 14 days since this agreement



is signed, the Customer does not have the right to withdraw the agreement after the Project is accomplished.

- 12. To exercise the right to withdraw this agreement the Customer has to inform the Researcher about the withdrawal by e-mail as well as by phone.
- 13. Should it be the case this agreement is withdrawn, the Researcher will return by PayPal the research cost indicated in paragraph 7 within 14 days since the withdrawal.
- 14. Should it be the case the agreement is withdrawn during the process of accomplishing the Project (such as travel to the archive), the Customer agrees to cover the costs spent on the Project before withdrawal.
- 15. The Researcher has right to hire other well qualified researcher to fulfill obligations resulting from paragraph 1.
- 16. This Agreement shall be governed by the laws of Poland, without regard to its conflict of laws principles. Any dispute arising out of or relating to this Agreement shall be resolved exclusively in the district court of Wrocław, Poland.
- 17. If requested, the Customer agrees to provide the Researcher notarized power of attorney allowing the Researcher to carry out the research in archives and complete the Project.
- 18. The customer agrees to credit the researcher for carrying out the research on the Project in any publicity material and oblige others who relies on the Project outcome in their publicity material to credit the Researcher. The credit should include the Researcher's name ("Tomasz Jankowski") and his website name ("Jewish Family Search"), if possible, linked to http://jewishfamilysearch.com.
